ORDER

In order to prevent the spread of COVID-19 in East Siang District, lockdown of 7 days w.e.f. 1/08/2020 to 7/08/2020 is hereby declared in Pasighat township area including rural peripheries, Ruksin Sub-Division and Sille-Oyan Circle with the following restrictions/exemptions:

1. All shops/markets will remain closed. Home delivery will be permitted. Smt. Nancy Yirang, EAC-cum-Nodal Officer (Supply) should ensure operation of the existing home delivery mechanism. ADC Ruksin and CO Sille-Oyan should devise a similar mechanism in their respective jurisdiction.
2. APMC should devise a mechanism for home delivery of vegetables. District Agriculture Officer (DAO), East Siang should ensure the same.
3. Movement of people including in vehicles will not be permitted.
4. Domestic flight operations will remain suspended.
5. Inter district and inter-state movement of people will not be permitted except for emergencies. Procedure for applying will be as laid down in the order issued by this office vide No. DCP/MED/COVID-19/2609 dated 18th July'2020 & No. DCP/MED/COVID-19/2625 dated 20th July'2020. Prior permission should be taken from DC's Office, Pasighat 48 hours in advance at mail ID districtnocovid19esd@gmail.com and only on working days. The person concerned should travel only after receiving permission in written from DC Office, Pasighat. Further all SoP and directives given in the aforementioned orders should be observed.
6. Any permission for movement should be applied 48 hours in advance and only on working days in the mail ID districtnocovidesd@gmail.com
7. Except DC Office, Police, Health, Disaster Management, Courts, Fire & Emergency Services and Govt. Offices providing essential services like Power, water, sanitation, highway all other govt. offices should operate through "Work from Home". All HoD/HoOs should ensure the same.
8. All Govt. Officials belonging to the above offices will be permitted to travel with a valid Govt. ID Card. All other officials shall work from home.
9. All commercial & private establishments shall remain closed except:
 - a. Banks & ATMs.
 - b. Health facilities & Pharmacies.
 - c. Telecommunication, broadcasting & internet services.
 - d. Print & Electronic media.
 - e. e - Commerce and home delivery services.

10. All Transport Services will remain close except:

- a. Transportation of essential goods only. However as laid down in the order issued by this office vide No. DCP/MED/COVID-19/2625 dated 20th July'2020, prior permission for entry of essential goods vehicles into the district should be taken from DC's Office, Pasighat 2 days in advance at mail ID districtnocovid19esd@gmail.com and only on working days.

- b. Fire, Law & order, emergency services and Health Services.

11. Due to the current sowing season, Agri-Horti activities will be permitted. However social distancing should be maintained while carrying out these activities.

12. No public gathering including social/political/academic/cultural/religious/sports/entertainment etc is permitted. In case of funerals, congregation of not more than 20 persons will be permitted.

13. The Nursing Officer Recruitment Examination for East Siang District scheduled to be held on 02/08/2020 stands postponed till further order.

Violation of these lockdown directives will be liable for prosecution under Section 51 to 60 of the Disaster Management Act, 2005 and Section 188 of IPC.

The Superintendent of Police, East Siang and all admin officers of the district are enjoined to enforce the above order in letter and spirit throughout the district.

This order is being issued under Disaster Management Act, 2005 and Epidemic diseases Act 1897.
