NOTIFICATION

Bhubaneswar, dated 29<sup>th</sup> January, 2021

No.LESI-LL2-LABGNC-0005-2020 666 /LESI, Whereas the draft of certain rules further to amend the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Odisha Rules, 1980 was published as required by sub-section (1) of section 35 of the Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (30 of 1979) in the extraordinary issue No.1454 of the Odisha Gazette dated the 26<sup>th</sup> November, 2020 under the Notification of the Government of Odisha in the Labour and ESI Department No. LL2-LABGNC-0005-2020-6109/LESI, dated 26<sup>th</sup> November, 2020, for information of all persons likely to be affected thereby and objections and suggestions were invited in respect of the said draft within a period of forty-five days from the date of publication of the said notification in the Odisha Gazette;

And whereas, no objection or suggestion is received from any person within the period so stipulated above in respect of the said draft;

Now, therefore, in exercise of the powers conferred by section 35 of the Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 the State Government do hereby make the following rules further to amend the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Odisha Rules, 1980, namely:—

1. (1) These rules may be called the Inter State Migrant Workmen (Regulation of Employment and Conditions of Service) Odisha Amendment Rules, 2020.

(2) They shall come into force from the date of their publication in the Odisha Gazette.

2. In the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Odisha Rules, 1980, for sub-rule (2) of rule 15, the following sub-rule shall be substituted, namely:—

“(2) The application shall be made in Form IX electronically not less than thirty days before the date on which the licence expires, and if the application is so made, the license shall be deemed to have been renewed.”
